## **NGO Registration & Fundraising Process**

### Registration

NGOs must register on the UWBe Philanthropic microsite and upload the following documents for verification and due diligence. To ensure smooth onboarding and compliance with statutory and financial due diligence standards, UWBe requires the following documents from each NGO partner. These documents are essential for verifying organizational legitimacy, financial discipline, and regulatory adherence.

### **Documents for Statutory & Financial Due Diligence**

- 1.\*Registration Certificate of the NGO (Under Societies Registration Act 1860 / Indian Public Trust Act / Section 8 of the Companies Act).\*
- 2.\*Renewed 80G Certificate (Proof of eligibility for tax-deductible donations).
- 3.\*Renewed 12A Certificate (Verification of exemption status under the Income Tax Act).
- 4.\*CSR-1 Form (Required for receiving CSR funds from companies.
- 5.\*PAN Card of the Organization
- 6.\*NGO DARPAN ID
- 7.\*Head of the Organisation (CEO/ED/MD): Name, Email ID.
- 8.\*Accounts/Finance Head: Name, Email ID, and Contact Number
- 9.\*Direct SPOC for this initiative: Name, Email ID, and Contact Number
- 10.\*Cancelled Cheque (Domestic Account) (For validating bank details for fund disbursals).
- 11.\*Registered Address Proof (Recent and valid supporting documents A copy of a recent utility bill (electricity, water, or gas bill) or house tax receipt or rental bill no older than two months.)
- 12.\*Authorized Signatory Name, ID (To validate the identity and authority of the individual acting on the NGO's behalf; ID: Aadhaar, Passport, PAN, Driving License; Proof of Authorization: Board resolution, or NGO Darpan authorized list, or Signed authorization letter on NGO letterhead)
- 13. FCRA Registration
- 14. List of Current Board Members (Including designation, tenure, and professional background wherever available).
- 15.\*Income Tax Return (ITR) Acknowledgements
  - (a) (FY 2024-25)
  - (b) (FY 2023-24)
  - (c) (FY 2022-23)


On successfully registering, the NGO gains access to various fundraising opportunities and platforms associated with the event, helping raise critical funds and increase the visibility.

Once UWBe completes the verification process, the NGO will receive an email confirmation with their portal page links. These dedicated NGO pages will allow the NGOs to showcase their work and appeal to their donors for donations.

# **Raising Funds**

The 2026 edition of TCS World 10K Bengaluru presents multiple ways for NGOs to raise funds. These modes are further elaborated in this structure. UWBe encourages NGOs to recognize their own strengths and choose all or a combination of modes which will work best for the organization.

### 1. Individual Fundraisers

**An Individual Fundraiser,** is someone who seeks to make a difference by raising funds for an NGO of their choice, registered with the Philanthropy Partner, to support a cause the person is passionate about.

The platform recognises these individuals, and supports & encourages them to raise funds. As the fundraising amount increases, individuals can achieve higher levels of recognition.

As an Individual fundraiser, you have to create a your fundraising page on the official UWBe philanthropic portal. You can set a personal fundraising goal and commit to collecting donations for your chosen registered NGO.

#### **Individual Fundraiser Registration Process**



Once the fundraising page is set up, you can request for donations from your friends, family, and colleagues (the "donors") and acquaintances. The donations are processed through the secure event-affiliated payment gateway and routed to your selected NGO.

NGOs that have successfully used this segment in past editions have tapped into their networks – including board members, staff, longstanding donors, volunteers, runners, students, and other supporters – to become fundraisers.





Anyone can be a successful fundraiser; all it takes is belief in the cause and the willingness to seek support on the NGO's behalf.

# Categories of Individual Fundraisers

### **Base Category:**

The philanthropy pillar empowers everyone to raise funds and create impact—no matter the amount. Based on minimum funds raised (as specified below), individuals are recognized under the Gold, Silver, and Bronze categories.

Bronze: ₹10,000- ₹24,999/-

Silver: ₹25,000-₹49,999/-

Gold: ₹50,000-₹99,999/-

#### Level 1: INDIVIDUAL FUNDRAISERS

1. CHANGE MAKER (₹1 Lac - > ₹2 Lac)

An individual who fundraises a minimum of ₹ 1 lakh in donations for a chosen NGO.

2. TRAILBLAZER (₹2 Lac -> ₹4 Lac)

An individual who fundraises a minimum of ₹ 2 lakhs in donations for a chosen NGO.

#### Level 2: INDIVIDUAL FUNDRAISERS

3. IMPACT CREATOR (₹4 Lac - > ₹ 7Lac)

An individual who fundraises a minimum of ₹ 4 lakhs in donations for a chosen NGO.

4. CHAMPION (₹7 lac & above)

An individual who fundraises a minimum of ₹ 7 lakhs in donations for a chosen NGO.

### Level 3: Young Fundraisers

This fundraising category celebrates young philanthropists and their commitment to make a difference.

Fundraisers below the age of 18 years (as on 25th April 2026) and fundraising a minimum amount of ₹10,000 for their chosen NGO/s fall under this category.

### Level 4: Young Achievers

A Young Fundraiser, fundraising a minimum amount of ₹25,000 for the chosen NGO/s, will be recognised as a Young Achiever.

### 2. Corporate Participation

The Corporate Teams category enables companies to field employee teams at the TCS World 10K Bengaluru while supporting a cause or NGO of their choice through charitable contributions. It offers a powerful platform to boost employee engagement, promote well-being, and drive social impact. Participation is coordinated through a designated Single Point of Contact (SPOC) to ensure smooth execution. Companies may support any NGO listed with the philanthropy partner, UWBe. If a preferred NGO is not registered, UWBe will facilitate its onboarding and registration for the event.


### Who is a Corporate Participant?

A Corporate, in the context of the TCS World 10K Bengaluru, is a registered business entity that formally participates by mobilizing employees to run and fundraise—aligned with its CSR and employee engagement objectives.

#### Corporate participation is driven by:

- Demonstrating commitment to social responsibility by supporting a registered NGO aligned with their mission and statutory CSR objectives.
- Creating a culture of fitness, teamwork, and purpose-led participation, strengthening employee morale and pride.

They can make a direct financial contribution, often through an upfront, non-refundable lump sum contribution to secure guaranteed race slots for their employees (Corporate Teams).








A SPOC (Single Point Of Contact) assigned by the Corporate registers the 'Corporate' on the UWBe philanthropic portal. They also select the specific registered NGO they wish to support and set a collective fundraising goal.

#### **How Corporates Mobilize and Contribute Funds?**

Corporates use a combination of direct funding and mobilized employee fundraising, making their contribution distinct from individual or group efforts:

### **Corporate Fundraising Strategies**



**Tracking and Recognition**: The UWBe portal dynamically tracks the total funds raised by all employees, showcasing the Corporate's progress on a dedicated group leaderboard to qualify for recognition levels.

UWBe can provide details of all employee donations made through the philanthropic portal and the Corporate can match such donations through cheque/direct transfer to UWBe.

### **Corporate Tent**

This is a unique privilege for Corporate Teams participating through philanthropy. On race day, event promoters set up a dedicated Corporate Teams Tent in the holding area-serving as an exclusive engagement and networking zone for employees.

The tent functions as a one-stop destination for:

- Medal and refreshment collection
- Team networking and engagement
- Enjoyable activities including games, Zumba sessions, photo booths, and team challenges

This curated experience ensures that corporate participants enjoy a memorable and differentiated race-day journey at the TCS World 10K Bengaluru, extending their experience beyond just the run.






### **Fielding Corporate Teams**

By fielding your own Corporate Team, your company doesn't just participate in the TCS World 10K Bengaluru – it becomes a **visible force for good.** Teams unlock guaranteed race slots for employees, build pride and wellness, and rally the workplace around a shared cause.

Every mile your employees run strengthens your brand's purpose, deepens CSR alignment, and helps your supported NGO accelerate real impact on the ground. Whether you start with 10 or 75 runners, every team becomes a movement-builder, proving that collective action inside the workplace can transform communities outside it.

The table below mentions the minimum donation amounts to be made against each team size. Being part of a Corporate team, employees can choose to run in any of the race categories - Open 10K, Majja Run, Champions with Disability or Sr. Citizens' Run; such participation is subject to availability of running slots in desired race category, and on first come first serve basis.

To register, companies must confirm the team size/s they wish to avail of with United Way Bengaluru and make a non-refundable donation. This includes their donation to UWBe and the selected NGO/s (which must be registered with UWBe for the TCSW10K Bengaluru 2026).

Companies wishing to contribute from their CSR budget and in accordance with CSR law should opt for the split option. In this option, the contribution is made in two separate parts, with one part being transferred directly to the chosen NGO and a separate cheque to be issued to UWBe for the administrative fees. . Companies opting to contribute not from their CSR budget can make a single donation to UWBe, and UWBe will disburse the appropriate amount to the selected NGO. In either case, the contributed amount is verified.

\*Additional team members can be added at a cost of ₹10,000 per member beyond the specified team size and up to a maximum of 10.

The Corporate Teams Participation & Contribution Cost does not include the event's run registration fee for individual team members. These need to be paid additionally, depending upon the race category chosenby individual team members, to the event promoter (via cheque/ DD/ Bank Transfer) in favor of 'Procam International Pvt. Ltd.'. The applicable run registration fees must be paid to Procam on or before the deadline (to be informed) and it will be over and above the service charges.

Donations once made will not be refunded under any circumstances whatsoever.

## 3. Institutions or Community Groups

Institutions and community groups—whether running clubs, RWAs, universities, schools, or collective associations—are at the heart of the TCS World 10K Bengaluru's philanthropy movement. Their participation goes beyond running; it builds a shared culture of giving, friendship, and civic pride.

When neighbourhoods, campuses, fitness groups, and community circles unite around a cause, they unlock the power of peer influence, storytelling, and local leadership. These institutions mobilize runners across age groups, neighbourhoods, and student communities, turning a single event into a citywide movement of generosity.

As movement-builders, not just participants, they create community-driven philanthropy that expands beyond race day and strengthens Bengaluru's identity as a city that runs—and gives—together.

A Team Representative/Leader registers the 'Institution/Community Group' on the **UWBe philanthropy portal**, selects their NGO partner(s), and sets a collective fundraising goal.

The Institution/Community Group can now invite their members and their extended network to donate to the cause selected by the group. Group can also encourage their members to start their own fundarising campaigns, whereby the member is not only recognised as an individual fundraiser, but the amounts so raised add up to the group's total. Some groups may also choose to make a direct lump-sum contribution to support their chosen cause.

Throughout the campaign, a live leaderboard on the UWBe portal tracks progress and visibility, helping groups qualify for recognition milestones.

Bengaluru's strong culture of fitness and community spirit makes Institutions and Community Groups powerful champions of social causes through the TCS World 10K.

### 4. Contribute to A Cause (popularly called as Top-Up Donation)

All participants at the TCS World 10K Bengaluru are encouraged to make a contribution while registering for their run. "Contribute to a Cause" is a powerful way for runners to turn their participation into purpose. You can choose to support a cause close to your heart whether by donating directly or fundraising for an NGO of your choice.

Your run becomes a step toward social change.

**During Registration:** Once the runner is registered on the Procam Runner Registration page, provide an option to donate on the registration portal itself along with the registration fees.

# 5. Charity Bib

To enable philanthropy at the TCS World 10K Bengaluru 2026, event promoter reserves certain number of bibs for charity A minimum amount of agreed between UWBe & NGO for designated charity or cause.

These Charity Bibs give runners a guaranteed entry even if general registrations are closed – by donating to a cause they believe in.

### **Key Highlights**

- Direct Support: Runners obtain Charity Bibs directly from NGOs, contributing to the cause they care about.
- Guaranteed Entry: Charity Bibs provide guaranteed race entry, even if general registration closes.
- **Exemption in Timing Criteria:** Runners with Charity Bibs enjoy exemptions from standard timing requirements.
- **Fundraising Flexibility:** 
  - 1. Minimum donation per race category is set to ensure fairness among NGOs.
  - 2. NGOs can request higher donations from participants if desired.
- Visibility for Causes: Runners display the NGO's name on their bibs, proudly showcasing their support.
- Limited Availability: Issued on a first-come, first-serve basis. NGOs can request additional bibs while they remain available with organizers.
- Fundraising Agreement: Minimum donation amounts are mutually agreed between UWBe and the NGO for the designated charity or cause.







#### For NGOs:

NGOs can reach out to UWBe and request charity bibs for distribution to their patrons. The NGOs can include a mark-up over and above the minimum amount prescribed by UWBe.

UWBe will also reserve a certain number of bibs for the NGOs that performed well in the past years.



**Early Bird Incentive Bibs:** UWBe will reserve a certain number of charity bibs for NGOs completing their onboarding and secure their first 10 donations from their individual fundraisers for the first 5 NGOs.



**Performance-Linked Bonus Bibs:** UWBe will award bonus charity bibs to NGOs that reach specific fundraising milestones (e.g., ₹5 lakhs raised by January 31st).

Minimum amount prescribed for each charity bib: ₹5000. (UWBe retention per bib: ₹500)


### **Charity Bib Registration Process**

In this edition, NGOs can utilize as many Charity Bibs as required, issued on a first-come, first-served basis.

#### **Key Guidelines:**

- Only 1 bib is allotted at a time. NGOs can convert this bib to any race category until bibs
  of that category are available. A new bib is issued only after the previous one is utilized.
- High Performing NGOs (from previous editions): Receive 2 bibs at a time.

# Charity Bib Reservation Process for NGOs




Note: This process ensures fairness and allows maximum participation while maintaining transparency in allocations.





# Charity Bib Registration Process for Runners



### **Charity Bib Donation Modes**

NGOs can receive contributions:

- Online through the UWBe fundraising portal
- Offline via cheque / direct bank transfer (with required details submitted to UWBe)

A donation receipt with tax exemption benefit will be issued to the donor by UWBe.

### **Charity Bib Collection**

- All Charity Bibs routed through NGOs will be handed over at the UWBe counter at the Expo.
- NGOs are encouraged to personally hand over bibs to supporters with a thank-you kit to build donor relationships.
- If an NGO cannot facilitate distribution, UWBe can support with advance intimation.

### **CXO Social Impact Grant**

The CXO Social Impact Grant recognizes corporate leaders who drive exceptional fundraising, storytelling, and community outreach during the TCS World 10K Bengaluru. CXOs are positioned not just as runners or supporters, but as grant-makers who reward the most impactful NGOs on our platform.

### Why This Matters

This grant helps high-impact NGOs:

- Bridge funding gaps for grassroots programs
- Pilot innovative ideas and community solutions
- Strengthen core capabilities such as leadership, data systems, training, and institutional capacity
- Sustain long-term impact beyond race day

Each CXO creates a personal impact grant, which is awarded to a shortlisted NGO after a transparent assessment of:

- Fundraising performance
- Community engagement
- Storytelling effectiveness
- Demonstrable impact and financial accountability

### **CXO Social Impact Grant Process**



#### **Grant Utilization & Transparency**

NGOs use the grant for program expansion, innovation, capacity-building, or piloting new ideas. UWBe oversees reporting and ensures transparent use of funds.

Every CXO runner becomes a force multiplier – a champion who fuels impact, rewards excellence, and accelerates innovation across Bengaluru's NGO ecosystem.






## **NGOs Privilege Levels**

To reward NGOs that actively participate via the UWBe and TCSW10K platforms, a Privilege Level System has been introduced.

**Purpose:** Recognize NGOs based on their level of participation, not the quality of their work. Participating NGOs will qualify for the Privilege levels the basis of certain indicators, each carrying specific points. These points cumulatively determine an NGO's Privilege Level. Please note that the Privilege Level is not an assessment or rating of an NGO's programme work, but rather a reflection of its engagement and participation in the TCSW10K platform.

- NGOs can continue to improve their Privilege Level until 9th May, 2026
- However, Race-Day benefits will be based on the Privilege Level as determined on 8th **April**, 2026

The NGO page will mention the privilege level, which is not a rating of their work but indicates their TCSW10K participation level. Achieving a privilege level qualifies the NGO for various incentives during the event.

# **Digital Recognition Tools**

- **Virtual "Wall of Impact"** post-event, highlighting names of contributors across all levels. This will be hosted on the philanthropy portal of UWBe.
- E-mail "Thank You" Campaigns personalized by contribution levels.





# **Retention Fees**

Retention fees are modest administrative charges applied to select donation streams (e.g., corporate contributions, contribute to a cause, charity bibs) to cover the operational costs of managing the philanthropy platform. These include donor servicing, NGO onboarding, payment gateway absorption, training, reporting, and audited disbursements.

## **Key Takeaways**

- 1. Fundraising can start immediately once the NGO page is set up and the "Donate" button is activated.
- 2. The last date to fundraise is Saturday, 9th May 2026
- 3. For donations made on UWBe philanthropy platform till 31st March 2026, NGOs would be responsible to file and dispatch the 10BE forms to their respective donors no later than 19th April 2026.
- 4. All donations received on and after 1st April 2026 will fall into the financial year 2026-2027. NGOs will be responsible for providing the 10BE to the respective donors.
- 5. All NGOs will be required to read and accept the Data Protection Policy of UWBe.
- 6. Terms and conditions as put out by UWBe at the time of NGO registration, and the event rules and regulations, will be applicable to all NGOs registered with UWBe for the 2026 edition of TCS World 10K Bengaluru.
- 7. Cash WILL NOT be accepted by UWBe.
- 8. UWBe will forward all legally required details of donors to respective NGOs within 15 days of the donations made.
- 9. Donations made will not be refunded for reasons whatsoever.
- 10. Procam International (Event Promoter) will oversee all event registration and event related queries.
